GENERAL

Tempus-Rex offers the T-Rex mobile time capture tool and supporting TEMPUS-REX.COM web site to facilitate capture, presentation, and downloading your time based data.

The Services that you will use include the applications, interfaces, web site blogs, forums, knowledge bases, and other tools associated with the Tempus-Rex product. If you use Tempus-Rex Services in any way, you are agreeing to comply with the terms and conditions that follow.

The relationship you are establishing is with Tempus-Rex. The primary place of business of Tempus-Rex is 2360 Notre-Dame West, Suite 310, Montreal, Quebec, Canada, H3J 1N4.

The Terms and Conditions that you are agreeing to may be updated. If the Terms of Service are updated and you are a current customer of Tempus-Rex, you will be notified via e-mail. If you are not a customer at that time, you remain bound by the Terms and Conditions in effect at the time that you used the Services.

The Tempus-Rex Services are the intellectual and physical property of Tempus-Rex. The Services are protected by copyright, trade secret, patent laws, and other proprietary rights and laws.

You agree not to use the application or Services provided in any way, except as intended. You may not resell, reuse, or reverse engineer the applications, or otherwise steal the intellectual property that is Tempus-Rex.

You understand that if you violate the spirit and intentions of this agreement you may be prosecuted.

ACCEPTABLE USE

1. Tempus-Rex allows only appropriate content on its blogs, information exchanges, interactive user forums or other similar media. Inappropriate content may be; racist, sexist, lewd, inflammatory, false or illegal. It may also be links or directions to inappropriate content. At the sole discretion of Tempus-Rex, this material will be removed and Services may be terminated.
2. Tempus-Rex does not allow access via unacceptable automated access methods like chat bots, scripts, or other information gathering applications, unless approved by Tempus-Rex. Designation of acceptable access methods is at the sole discretion of Tempus-Rex. Unacceptable use may result in termination of Services.
3. You may not use Tempus-Rex for any purposes considered illegal where you use it.

PRIVACY POLICY

It will never be sold to a third party for marketing, it will never be leased to a list provider for sales campaigns, and it will never be used by us in any way that you have not requested.

PROTECTING YOUR DATA

1. You understand that you are responsible for protecting the confidentiality of passwords associated with your Tempus-Rex account.
2. You agree that you will be solely responsible for all activities that occur under your account.
3. If you see unauthorized use of your password or of your account, you agree to notify Tempus-Rex immediately at support@tempus-rex.com.

CHARGES, TAXES AND TERMINATION

1. You agree to pay the applicable service fee for the service you have selected via PayPal.
2. You may terminate the Services at any time by cancelling the direct payment via PayPal. Services will be provided and your data maintained until the end of the period that you have paid for. Your data will be deleted 60 days after the termination of Service.
3. Unused Services will not be refunded.
4. You are responsible for any applicable taxes.
5. The agreement will remain in effect as long as you continue to make payment for the Services.

TEMPORARY USE LICENCE

Whether under the trial program, or as a paid subscriber, you are granted a non-exclusive, non-transferable temporary license, subject to the terms and qualifications of the Terms and Conditions, to use the T-Rex mobile Services on a single Mobile Device.

THE NATURE OF THE PRODUCT

1. Tempus-Rex provides the Services on an "as is" basis. Documentation, online training and support are provided based on reasonable and expected market requirements.
2. The quality and validity of the data you capture and enter into Tempus-Rex is your responsibility. Tempus-Rex in no way validates or corroborates your data.

LIMITED LIABILITY

Under no circumstances will Tempus-Rex be liable for any direct, indirect, or consequential damages that result from the use of or inability to use the Tempus-Rex.

ELIGIBILITY TO AGREE TO THE TERMS OF SERVICE

You must be eligible to use the Services of Tempus-Rex. If you are not eligible, you are not allowed to access the application or Services. If you are ineligible, you may face the appropriate legal consequences. You are ineligible to Agree to the Terms of Agreement or use the Services of Tempus-Rex if;

1. You are not 18 years of age.
2. You are for any reason legally ineligible to agree to the Terms of Agreement.
3. Agreeing to the Terms of Agreement breaks laws in the jurisdiction in which you reside or the jurisdiction in which you will be using the Services.
